Course contents

Historical Linguistics. History of the English language. Phonetics and Phonology of the English Language.

Course contents (extended version)

1. Historical Linguistics – the comparative method and the reconstruction of languages
 - The Proto-Indo-European and the Indo-European families: the Germanic branch
 - Phonetic laws and phonetic evolution processes
 - Semantic and syntactic evolution. Grammaticalization
2. The History of the English language
 - Old English, Middle English and Modern English; invading peoples and their influence
 - Language change: phonological, morphological, syntactic and lexical change
 - Relevant texts of each period
3. Phonetics and phonology
 - Articulatory phonetics and articulatory description of vowels, consonants, and glides
 - Phonology of English (long and short vowels; distinction of consonant sounds)
 - Phonemes and allophones. The phonemic system. The minimal pair test
 - Contrastive distribution, parallel distribution, and complementary distribution
 - Phonotactic restrictions
 - Allophonic processes: aspiration, assimilation, elision, and insertion
 - Suprasegmental features: stress and intonation
 - Prosody: the syllable
