Course contents

Distinction between revising and editing and how they complement each other. Main norms, style sheets and professional practices. Types of edition and revision. Strategies, principles and procedures in the process of revision and edition, as well as a linguistic task and text production. Varieties of easy and plain language. Practice of revision and edition of diversified texts and authentic projects.

Course contents (extended version)

1. Revision as a quality parameter (ISO 17100/2015).
2. Concept of revision and editing: similarities and differences.
3. Revision - linguistic patterns, communication and publishing standards:
 - Portuguese standards; in-house standards and style guides
 - error identification and symbols used
 - parameters, degrees and procedures of revision; proofreading.
4. Editing: stylistic, structural, content and consistency editing; tools and conventions.
5. Self-revision, hetero-revision and comparative revision (original and translation).
6. Varieties of plain and easy language: norm and examples in Portugal and internationally.
