Course contents

1. Territorial, political and administrative organisation of the British Isles
2. 1066 and at the formation of a nation? (mitos e realidade)
3. The Middle Ages: progress and turmoil
4. The Sixteenth Century in Britain: Renaissance and Reformation; the Tudor Dynasty: major achievements and failures.

Course contents (extended version)

1. Territorial, political and administrative organisation of the British Isles:
 - Geographical and administrative distinctions
 - Monarchy and government (constitutional monarchy)
 - Life and work in 21st century Britain
2. "1066 and after?" (myths and reality). The formation of a nation:
 - Battle of Hastings: importance and symbology (the Bayeux Tapestry)
 - Norman influence in Britain
3. The Middle Ages:
 - The Feudal system
 - Relations with France, the 'Hundred Years' War
 - The Magna Carta and the (so-called) beginning of Parliament
 - Fourteenth century crises in England (The Black Death, (1348-1351; the peasants' revolt 1381)
 - The civil conflicts of late-fifteenth century: the Wars of the Roses (H. of Lancaster vs H. of York)
4. The sixteenth century:
 - The Renaissance: cultural, social and economic developments;
 - Utopian humanism in Thomas More's Utopia
 - Tudor England
 - Henry VIII and the Henrician Reformation. Edward I and the Protestant Reformation
 - The importance of the Act of Supremacy in the establishment of national identity, Erastianism
 - Religious struggle (Protestantism vs Catholicism). Reformation and Counter-Reformation (Mary I)
 - Elizabeth I and the Elizabethan Settlement
 - The Golden years; the Spanish Armada; cultural growth. Transoceanic expansion
