Course contents

1. The 17th century in Britain: social, political and cultural insights; Stuart England; the Civil Wars; the Cromwell protectorate; the Restoration; the so-called 'Glorious Revolution', the Bill of Rights, the idea of liberty
2. The 18th century: The age of revolutions; The American and French Revolutions; England and the French Revolution; the influence of the Enlightenment and the Age of Reason on the revolutions
3. The Industrial and Agrarian Revolutions in Britain; economic liberalism.

 - Stuart England
 - Civil Wars
 - The Cromwell Protectorate
 - The Restoration Period
 - The 'so-called' Glorious Revolution and the Bill of Rights

2. The 18th century: The Age of Revolutions:
 - The American Revolution: the meaning and consequences of the American Bill of Rights
 - Cause and consequences of the French Revolution
 - Britain and the French Revolution
 - Pamphleteers and the establishing of popular literature
 - Political writers: Edmund Burke, Thomas Paine and Mary Wollstonecraft
 - Enlightenment and the Age of Reason
 - The Agrarian and the Industrial Revolutions
 - Economic, social, political, religious and cultural consequences of the Industrial Revolution
 - The stratification of social classes: the upper class, the middle class and the working class
