Course contents

Linguistic items and writing models appropriate to the CEFR C1. 2 level. Texts for reading and writing, Vocabulary in the areas of - lexical fields, collocations, word families, fixed phrases, idioms and phrasal verbs. Advanced studies of grammar, functional language for use in daily lives.

Course contents (extended version)

1. Grammar: past verb forms; passive voice; gerunds and infinitives, linking words, etc.
2. Writing: letters, articles, reviews, etc.
3. Vocabulary: common collocations, formality, idioms, prepositional phrases, etc.
4. Topics: Our People, Mastering Languages, All in the mind, Office Space, Dramatic Events, etc.
