### Course contents

1. Introduction to Audiovisual Translation Studies:
  - terminological variation in the area;
  - the audiovisual text and its technical, communicative and pragmatic features;
  - AVT types;
  - audiovisual genres.
2. Types of subtitling according to formal, linguistic and technical criteria.
3. Advantages and disadvantages of subtitling versus dubbing.
4. National and international norms and recommendations for interlingual subtitling.
5. Subtitling of short films and excerpts of various films.

### Teaching and learning methods

Apart from the indispensable theoretical presentations, the curricular unit will be based on the analysis of subtitled products and on the discussion of the choices made by the translators. Students will have to apply the acquired knowledge in short subtitling projects to be presented to the class. Other exercises may also be implemented, e. g. "blind peer" revision and subsequent justification.

### Assessment methods

1. Continuous - (Regular, Student Worker) (Final)
  - Intermediate Written Test - 40% (Exam focusing on interlingual subtitling.)
  - Intermediate Written Test - 30% (Project based on the subtitling of an IPB film.)
  - Projects - 30% (Personal project based on a short film to be chosen.)
2. Final - (Regular, Student Worker) (Final, Supplementary, Special)
  - Final Written Exam - 100% (Final exam focused on theory and practice.)
