  4. Light and Color properties: hue, lightness and saturation.

  5. The Body, the gesture and the Brush stroke in the operative process.

  6. Space and representation systems. Elements and studies of visual composition.

  7. The time, Idiosyncrasies of the coloring matters for below and beyond the theories of color.
