 From DADA to functionalism with recovery of craftsmanship and manual making Werbund and Bauhaus;
 The rediscovery of emotions, values of form and importance of the unconscious;
 Key Styles: Expressionism, Abstractionism, Suprematism, Surrealism, Modernism.

 4. The post-war, the neo-vanguards and postmodernity.
 The emergence of America as a power. The power of the information society, capital and technology;
 The replicates of counterculture to massification;
 From the functionalism revisited with the Ulm High School of Form to anti-design movements;
 Key Styles: Abstract Expressionism, Conceptual Art, Pop Art, Functionalism in Design;
 Fundamental Styles; Op Art, Happenings, Street Art, Video Art, Anti-Design; Postmodernism.
