6. Acquire knowledge about the employment contract, the subjects of the individual labor relations, the training and the content of the work contract and causes of termination;
7. Apply legal norms from an eminently practical perspective.

5. NOTIONS OF LABOR LAW
  - Concept, object and scope of labor Law.
  - Powers and duties of the employer.
  - Rights, duties and guarantees of the worker.
  - The contract of employment: concept and legal characterization.
  - Experimental period: concept and duration.
  - Workplace: concept and general principles, maxime the guarantee of irremovability.
  - Duration and organization of working time: basic concepts. Supplementary work. Night work.
  - The right to rest: the daily rests and weekly rest. Vacation. Holidays. Faults.
  - Retribution: general concepts, elements and modalities. Form, place, time and proof of compliance.
  - Termination of employment contract: causes of termination; the principle of numerus clausus.

### Teaching and learning methods

The objective of the class is considered to be reached if in the end the student has understood these concepts and is able to apply them to situations of daily life, by application the sources of law.
