Learning outcomes and competences

2. Recognise the different types of commercial companies.
3. General description of the different types regarding the personal element, share capital, corporate responsibility, organisational structure and transfer of shareholdings.
4. Understand the "life" of commercial companies, from their incorporation to their extinction, including mergers, spin-offs and transformations.
5. Understand the specific nature of the personality and capacity of companies, the rights and obligations inherent to shareholdings, the difference between company patrimony, profit and reserves;
6. Understand how shareholders deliberate and how the management and representative bodies of commercial companies operate.
7. Solve illustrative practical issues in case law, taking a critical approach to the solutions found by the courts in a specific case.
