### Learning outcomes and competences

At the end of the course unit the learner is expected to be able to:

### Course contents

Identify problems / nursing diagnoses in mental health and psychiatry. Plan, implement and evaluate on mental health and psychiatric nursing care to the three levels of prevention. Patient dynamic observation with mental disorders with the principles of the nurse / user. Plan and implement nursing care respecting the technical scientific principles in order to help the user to reverse or minimize metal imbalance situations in the shortest time.

### Course contents (extended version)

1. Organization and functioning of Psychiatric services: outer query, the urgency and hospitalization.
2. Develop general care nursing skills in the area of mental health and Psychiatry.
3. Dynamic observation of the patient.
4. Application of the nursing process to the patient Psychiatric
5. Identification and prescription of nursing diagnoses in mental health and psychiatry.
6. Establishing a therapeutic relationship with patients with mental disorders.
7. Prescribed therapy delivery and assessing its effect acting accordingly.
8. Know and apply nursing techniques that aim at the relief of the wearer's mental discomfort.
9. Develop nursing care directed for the prevention and control fraudulent situations.
10. Preventing and identifying mental disorders never forgetting the organic aspect of the wearer.
11. Identify and apply the concepts of effective interpersonal communication.
12. Know and apply communication techniques in a professional context.
13. Identify and report anomalies of the patient, respecting the previous assumptions.
14. Construction of healthy environments mental health promoters seeking the maximum life of the wearer.
15. Develop and implement psychoeducational programs and training in Mental Health
