### Course contents (extended version)

1. Establishes help relationship with the old person/family
2. Applies nursing process to the elderly, aiming the improvement of his/her well-being
  - by promoting of self-care
  - delaying of dependency
  - enhancing residual capacity
  - Observing professional secrecy
3. Meets prescriptions of others and integrates interdisciplinary care
  - Observes and analyses prescriptions
  - Prepares, administers, records and observes effects of medication using the rule of the six rights
  - Uses aseptic technique
4. Identifies potential risk situations, implements care aiming the prevention/solution of the problems
5. Promotes and maintains a safe and therapeutic environment
6. Collaborates in management:
  - of nursing care
  - of others provided by other professionals
  - of material resources
7. Nursing registries
  - which reflect nursing practices and health outcomes sensitive to nursing care
8. Diagnoses, plans, implements and evaluates training activities and / or health education
9. Integrates research projects aiming professional development and improvement of users
