Course contents (extended version)

1. Interpersonal skills: professional ethics and legal practice:
 - Teamwork encouraging a climate of cooperation, promoting positive interpersonal relations;

 - Collaborates and performs' maskuriko catheterizations, intubations and other nursing techniques.
